- Memberships are on an annual basis. Your membership is effective on the date you sign and pay for your contract.
- Imbibe reserves the right to refuse service, as well as, access to the business to any person.
- Any membership charges or fees are automatically processed at the beginning of each month throughout the term of this contract.
- Imbibe reserves the right to amend the contract at any time.
- Memberships may be suspended or revoked for non-payment of a bill, breach of this contract, misconduct, unpaid fees or failure to adhere to any of the rules, regulations, and policies set forth by imbibe.
- Members are to comply with all local, state and federal laws. It is imbibe's policy that no illegal substances nor materials, including but not limited to, any firearms or weapons will be put or stored in any of the cigar lockers. The purposes of the lockers are to hold and store legal tobacco products and accessories (i.e. lighters, cigar cutters, ashtrays) that are incidental to cigars.
- Imbibe does not insure nor is responsible for any contents stored in the cigar lockers.
- Imbibe maintains a key to all lockers and we reserve the right to access the lockers at any time necessary by imbibe policy or by law.
